Surrender. In a dark, cold garage, I sat in my car and cried. Slowly, very slowly realizing that I had made a complete wreck of everything around me and was losing everything that was of any importance to me. Until this particular Tuesday, which was a regular Tuesday, just like every other wasted Tuesday which had since passed, I believed that I had everything under control and my life was still in working order.

It was in the morning

hours of this Tuesday, after I had dropped my kids off at school, I sat in my car broken – knowing that I could not keep drinking and knowing that I could not stop.

It appeared as a small thin sliver, just a slim fragment. It was so small at that point that if I hadn't been stretched to breaking, I may have missed it altogether. It was surrender. It was hope.

In my broken state of drunken stupor, a headache wanting form, I caught just a glimpse of hope. Hope that maybe I didn't have to keep living the way I had been living. Hope that someone could help me figure out how to stop viewing life through a half empty bottle and to stop squeezing every last drop of my existence out of it.

I was desperate for change, but desperately did not want to be an alcoholic/addict. I had spent so much time and energy trying to avoid this truth. Numbing myself for distraction...

#### To the Newcomer: Who is a Cocaine Addict?

Some of us can answer without hesitation, "I am!" Others aren't so sure. Cocaine Anonymous believes that no one can decide for another whether he or she is addicted. One thing is for sure, though: every single one of us has denied being an addict. For months, for years, we who now freely ad-

mit that we are cocaine addicts thought we could control cocaine when in fact it was controlling us.

"I only use on weekends," or "It hardly ever interferes with work", or "I can quit, it's only psychologically addicting, right?" or "I only snort, I don't base or shoot." or "it's this relationship that's messing me up."

Many of us are still perplexed to realize how long we went on, never getting the same

never getting the same high we got at the beginning, yet still insisting, and believing—so distorted was our reality—that we were...

#### **Our 4th Tradition**

"Each group should be autonomous except in matters affecting other groups or C.A. as a whole."

When I was new in the program I had no idea what "autonomous" meant. Webster's Dictionary defines it as "self-governing."

So when we talk about groups here they could be two or three people or as many as hundreds that comprise a group. They are free to set up their group as they wish as long as it doesn't negatively affect other groups or violate C.A. Traditions. So the watch words here are "injury and affiliation". We must not injure another group or (CA) as a whole nor affiliate with anything or anybody else like a hospital or a religious group or Dry Duck Hunters or Irish Only Crackheads.

In As Bill Sees It, Bill W. wrote, "We admit that we have character defects as a society and that these defects threaten us continually." (pg. 119).

The fourth tradition, when exercised, is similar to a 4th step. It suggests the group should take an honest inventory of itself when it plans to take any actions that might break any traditions, or would harm another group or person. The group ought to be making any important decisions via a group conscious, which is the ultimate authority.

The beauty of Tradition Four is it allows a meeting or groups to create their own customs and formats. This provides a great deal of diversity and variety of topics and environments.

In "Twelve Steps and Twelve Traditions", Bill W. reminds us that we are "Children of Chaos", and that we have the "right to be wrong" (pg. 146-147). We are also given Rule 62: "Don't take yourself too damn seriously", and that being able to laugh at yourself is the "acme of humility" (pg. 149)

Through my experience as a Director on the World Service Office Board (2002-2008) and as a Trustee on the World Service Board of Trustees (2004-2008) I believe at the service level Tradition Four is autonomy with responsibility and patience. Some would say of Tradition Four that it

leaves groups to do whatever they will learn, let them go. Some say what they do may have a very wide impact and we should delay and consult with the wider fellowship. Our experience showed us that most of us will fall somewhere in between.

At the group level, we always asked "What might this effect?" The guiding concern should always be "Does this action greatly affect (CA) as a whole?" We would start a pro and cons list and get it on paper. When doing Public Information service work we needed to consult with other groups and areas in the region before proceeding.

Being a group composed of children of chaos and ego driven individualists it is in our nature to defiantly test the boundaries, our 4th tradition, through the group conscious, provides a guide to group survival, and CA as a whole. The steps were created to help me prevent my suicide, the traditions were created to prevent our homicide. Remember Rule 62!

### San Diego Fentanyl-Related Deaths Increasing

According to a news release by San Diego county authorities, in 2020 fentanyl-related deaths increased 202% to 457 deaths compared to 2019's record setting year of 151 deaths.

Official project the number of deaths to continue to increase, projecting 700 fentanyl-related deaths for 2021.

"Fentanyl overdoes have happened in every part of the county an affect every demographic", warned the news release.

The county has started offering a reversal medication, Naloxone, to the general public, which can be obtained at several community based locations and clinics throughout San Diego.

Drug overdoses in San Diego County rose this summer as experts say the isolation and stressors of the pandemic took a toll on mental health.



...rather than healing the place within myself that I was trying to bury. There is no peace to be found when you are living in a place between fear and guilt.

The small glimmer of surrender that had overcome me, was all I needed to finally ask someone for help. I asked another addict for help, admitted that I was an addict and took that sliver of surrender

that felt like sunshine and ran with it.

My sobriety date is May 2, 2013. I don't know why on that Tuesday morning that glint of hope and surrender made it's way to light, but I am eternally grateful for it. CA has given me the outline for living life on life's terms, the tools to use when life gets crunchy around the edges. That little crack of sunshine turned into the grace

### Was I Willing to be of Service?

The background to this story is that I had a lot of trouble getting my laundry done before I got into recovery. Going all the way outside to where the washer was seemed long a long journey to me at the time. I showed up to a treatment center with a bag full of clothes that hadn't been washed in months. They encouraged me to wash my clothes right away, even though Tuesday was usually the day women had access to the laundry room.

Fast forward 15 months. I have worked all 12 steps and had a spiritual experience. I know exactly what I need to do to stay sober and I have a pretty good idea what everyone else should be doing too.

It's time to fill the service positions at the big meeting at the treatment center I attended. I'm thinking I should be GSR or something, but I was nominated to be the coffee maker. I was disappointed. The secretary asked me "Are you willing to be of service?" I begrudgingly said yes. The next week I show up 45 minutes early to learn how to make the coffee. The outgoing coffee maker sent me down the hall to the laundry room to fill up the pot with water. As I walked into that room and saw the washers and smelled the soap I came crashing back down to right size. I saw that I got the right commitment after all.

The first meeting of C.A. was held on Thursday, Nov. 18, 1982, at the Motion Picture Health and Welfare Fund building at 335 North La Brea in Hollywood, CA. Veronica Jo K. is the secretary and calls the meeting to order with a gavel and announces: "Welcome to the first

meeting of Cocaine Anonymous, a fellowship of men and women who share their experience, strength, and hope with each other and help others recover from their addiction." Cocaine Anonymous was officially "formed" on Nov. 23, 1982 by its founding members Johnny S., Ray G., and Gilbert M., all from Los Angeles, California. Tom K., the owner of an "entertainment industry sober living facility called "Studio 12" identifies the need for a group for cocaine-addicted people to talk about their struggles and sobriety.

... getting from cocaine what actually always eluded us. We went to any lengths to get away from being ourselves. The lines got fatter; the grams went faster; the week's stash was all used up today. We found ourselves scraping envelopes and baggies with razor blades, scratching the last flakes from the corners of brown bottles, snorting or smoking any white speck from the floor when we ran out. We who prided ourselves on our fine-tuned state of mind! Nothing mattered more to us than the straw, the pipe, the needle. Even if it made us feel miserable, we had to have it.

Some of us mixed cocaine with other drugs and found temporary relief in the change, but in the end, it only compounded our problems. We tried quitting by ourselves, finally, we managed to do so for periods of time. After a month, we imagined we were in control. We thought our system was cleaned out and we could get the old high again, using half as much. This time we'd be careful not to go overboard. But we only found ourselves back where we were before and worse.

We never left the house without using first. We didn't make love without using. We didn't talk on the phone without coke. We couldn't fall asleep; sometimes it seemed we couldn't even breathe without cocaine. We tried changing jobs, apartments, cities, lovers—believing that our lives were being screwed up by circumstances, places, people. Perhaps we saw a cocaine friend die of respiratory arrest, and still we went on using! But eventually we had to face facts. We had to admit that cocaine was a serious problem in our lives, that we were addicts.

#### In other News

Before cocaine was outlawed in 1914 under the Harrison Narcotic Act, it was marketed as a

it was marketed as a treatment for everything from toothaches and depression to hay fever and alcoholism.
